Total business licenses increased by 7% this year.

Code complaints of decreased by 18% but there has been a 3% increase of violations.

Small Emergency Care hospital broke ground recently at the corner of 23<sup>rd</sup>/Lee's Summit.

Animal Shelters in the area are having a crisis with too many animals. MO has many puppy mills and breeders which is resulting in the overabundance of animals.

Please spay/neuter our animals.

Geobond-council is working on trying to get the general obligation bond for the city. It is a cheaper way for the city to borrow money. They would like to apply this money to a new justice building, roads, bridges, possibly a rec plex like Lee's Summit to bring in income.

Homeless- This is a passion of Dr. Bridget McCandless, a member of the city council. The city has the Independence together program who work with CSL. Good Shepherd church is a drop in for homeless. Arch program started by fire department to assist with calls. The arch program will go to a call with EMS and 2 SWs to attempt to assist the homeless. They know the homeless by name in our area. Building a comprehensive health program that just got approval.
